The program provides financial assistance to students pursuing higher education, including enrollment in technical and vocational schools. For the 2026 academic year, Members First Credit Union of Florida will award up to four (4) non-renewable scholarships, each in the amount of **\$1,250**. These scholarships reflect the Credit Union's continued commitment to empowering young leaders who demonstrate academic achievement, personal integrity, and a dedication to serving their communities.

### Scholarship Eligibility Requirements

To be eligible, applicants must be graduating high school seniors or high school graduates enrolling as first-year, full-time students at an accredited college, university, or vocational institution. Applicants must maintain a minimum **3.0 GPA** on a 4.0 scale, be a **primary account holder** at Members First Credit Union of Florida and have at least one parent or guardian who is also a primary account holder in good standing.

Applications must include **one to four academic and/or personal letters of recommendation** and a **500-word essay** addressing one of the following topics:

1. How credit unions can better serve Gen Z members
2. How credit unions positively influence our communities

Essays will be evaluated based on clarity, depth of insight, and alignment with the mission and values of Members First Credit Union of Florida.
